THE CITY'S 311 OPERATORS ARE NOW ACCEPTING NEW PRIVATE PROPERTY REQUESTS. DPW APPRECIATES YOUR PATIENCE AS THE DEPARTMENT CONTINUES TO WORK THROUGH THE LARGE BACKLOG OF REQUESTS, AS CITYWIDE REMOVAL SERVICES HAD PREVIOUSLY BEEN SUSPENDED SINCE JULY 2020 AND NEW REQUESTS HAVE BEEN SUBMITTED SINCE GRAFFITI REMOVAL SERVICE WAS RESTARTED FOR PUBLIC PROPERTY.
